 - Teaching Strategies, LLC for August 31, 2025, to August 30, 2026, in an estimated amount of \$65,000 for software licenses
 - Lansing Sanitary Supply and Kalamazoo Sanitary Supply for July 1, 2025, to June 30, 2026, in an estimated amount of \$90,000 for custodial supplies
 - All Covered (Konica Minolta Business Solutions U.S.A.) for July 1, 2025, to June 30, 2026, in an estimated amount of \$60,000 for promethean interactive display systems
 - Michigan Rehabilitation Services (MRS) for October 1, 2025, to September 30, 2026, in an amount of \$60,000 for vocational rehabilitation services
 - Everway LLC for September 1, 2025, to August 31, 2026, in an amount of \$31,226.47 for special education curriculum

In other action, the Board:

- Authorized the superintendent to enter into an agreement with TMP for the architectural work on elements of facility improvements of the Long-Term Capital Plan as consistent with our strategic plan.



- Approved the Resolution of Tribute for Eric Lynch as presented.
- Approved the out-of-state student travel requests for the Wilson Talent Center programs for 2025-26 to attend the Close Up, Cook Around the World or the US Capitol Kitchen Tour; America's Beauty Show, Cedar Point, National Restaurant Association Show, Congressional App Challenge, HOSA, ProStart, and Skills USA events.
- Adopted the resolution to certify the 2025 winter tax levy.
- Authorized the Superintendent to finalize and execute an addendum with Westland Commerce Center, LLC, c/o NAI Mid-Michigan Property Management, for 2,700 square feet of space at 4409 Empire Way, Lansing, MI. Lease rates will be approximately \$7.11 per square foot for year one (\$1,600 per month), \$7.33 for year two (\$1,650 per month), and \$7.55 for year three (\$1,700 per month), plus NNN charges estimated at \$410.00 per month. This results in annual lease amounts of approximately: Year 1: \$24,120, Year 2: \$24,720, Year 3: \$25,320.
- Approved the 2025-26 Special Education Program student handbooks as presented.
- Approved the 2025-26 ASD classroom calendars for Leslie and Stockbridge as presented.
- Approved the FTE increase for an Audiologist as presented.
- Approved the 2025-28 salary schedule for the Superintendent as presented.
