

## **BOARD BRIEFS**

December 16, 2025

#### Presentation

Mike Lilly and Dan Lietz presented an update on Cyber Security Collaboration efforts at Ingham ISD.

Tyler Technologies for September 1, 2025, through August 31, 2028, in an estimated amount of \$35,793.82 annually or \$107,281.46 total for three years for renewal of Enterprise ERP software agreements with Muskegon Area ISD for Ingham ISD and three business services districts

### In other action, the Board:

- · Authorized the Superintendent to finalize and execute a three-year agreement with Salesforce, Inc. of San Francisco, CA in the amount of \$278,094 for Education Cloud, Tableau and Flex Credit licensing necessary to support projects such as the Constituent Relationship Management (CRM) system pilot defined in the 2025-2028 Ingham ISD Strategic Plan.
- · Authorized the Superintendent to execute an agreement with Servio Consulting, LLC of Frankfurt, IL in the amount of \$35,665 with a contingency allowance of \$14,335 for a total not to exceed \$50,000 for implementation and support services for Ingham ISD's Salesforce Education Cloud CRM pilot program.
- · Approved the request for increase in FTE for School Psychologist and Speech-Language Pathologist in early childhood services.
- Approved the request for a new grant funded LLG and Outreach liaison position, as presented.
- · Awarded a three-year contract to R & D Landscape LLC of Eaton Rapids, MI for landscaping (lawn care) and snow removal services beginning April 1, 2026, through March 31, 2029, at contract rates specified



on a per-unit basis with an annual unit rate increase of 3.5%. The total annual contract amount will be dependent on seasonal conditions and is estimated to range from \$110,000 to \$130,000 per year.

- · Authorized the Superintendent to execute an agreement with Spear Educational Consulting for an amount not to exceed \$86,500 for the expanded scope of work under the Section 35i Family Engagement grant for the period December 16, 2025, through May 31, 2026, and to acknowledge total contracted services of \$116,500 with Spear Educational Consulting for the 2025-26 school year.
- Approved the Special Education Bond Proposal Resolution to call for a special election on May 5, 2026, to ask voters to approve borrowing the sum of \$99,960,000 by issuing general obligation unlimited tax bonds for the purpose of capital improvements to special education center-based facilities.
- Accepted the Strong Beginnings Three-Year-Old Preschool Pilot Program funding under Section 32t and authorized the Superintendent to execute the grant agreement with Clinton County RESA Office of Innovative Projects for the first award period and any subsequent grant award periods. This authorization includes approval of the \$132,000 program allocation, along with additional start-up and transportation funds, as awarded.
- · Approved the resolution as presented for conditional application for Section 31aa school safety funding.
- · Awarded the TEC and WTC Network Refresh Project to MOSS of Grand Rapids, MI in the amount of \$317,628.15, plus a project contingency of \$20,000 for a total project cost not to exceed \$337,628.15.
